A. Introduction

- 1. This Policy ("Subscription Policy") sets out the terms and conditions ("Terms") which users of The Wizdom JournalTM website ("Site") agree to be bound by, in addition to providing consent to any Terms incorporated by reference or necessary implication, at the time of signing up for The Wize SubscriptionTM ("Subscription"), including during the operation of any free trial.
- All the terms and conditions stipulated in our Terms Of Service and Privacy Policy are taken to be a part of the Subscription Policy unless modified or replaced by the Terms contained in this document.
- 3. The Site operators ("The Wizdom Journal", "we", "us") may make changes to these Terms from time to time. If we make changes, we will provide you with notice of such changes, such as by sending an email, providing a notice through our Site or updating the date at the top of these Terms.
- 4. Unless we say otherwise in our notice, the amended Terms will be effective immediately, and your continued use of our Site after we provide such notice will confirm your acceptance of the changes. If you do not agree to all the amended Terms, you must stop using our Site.

B. Subscription Fee

- 6. The Subscription is subject to a monthly subscription fee ("Subscription Fee") of A\$10.00.
- 7. The Subscription renews automatically until it is cancelled. After initiating the cancellation of the Subscription, the Subscriber continues to be a Site member and enjoys all the Subscription privileges until the date upon which the Subscription Fee is next payable.
- 8. The Wizdom Journal does not offer refunds of the Subscription Fee, either wholly or in part.
- 9. For the avoidance of doubt, the Subscription Fee is payable in advance at the time of signing up for the Subscription (subject to the operation of any free trial at the time) and then on the same date each month, irrespective of the proportion of the month for which the Subscription is maintained.

C. The Rights & Obligations Of The Subscribers

- 10. For the avoidance of doubt, the terms and conditions that define the agreement between The Wizdom Journal and the Site users, as stipulated in our Terms Of Service and Privacy Policy, apply equally in respect of persons who sign up for the Subscription ("Subscribers") unless modified or replaced by the Terms contained in this document.
- 11. The Subscription allows the Site users to sign up as Site members and gives them access to all the documents, content, and other materials available through the Site ("Site Materials"). This does not apply to publications released by the Wizdom Journal on other platforms that are promoted or referenced in the Site Materials.
- 12. Except for access to the Site Materials not available to Site users other than the Subscribers ("Subscription Only Content"), the Subscription does not bestow any rights (in relation to intellectual property or otherwise) and/or



entitlements upon the Subscribers additional to those that define the relationship between all other Site users and The Wizdom Journal. Likewise, the Subscription doesn't diminish the obligations and/or liabilities of the Subscribers to The Wizdom Journal or any other parties in respect of their use of the Site and the Site Materials, and any matters arising from them.

Whilst The Wizdom Journal makes reasonable efforts to ensure that the Subscribers have an enjoyable and satisfactory experience with the Subscription, we do not offer any warranties in respect of the quality, accuracy, fitness for purpose and consistency of access to the Site Materials, including the Subscription Only Content. We do not offer refunds, either wholly or in part, in relation to complaints arising out of issues in this respect.
- 16. All Subscriptions are for the exclusive and personal use of the individuals signing up as the Subscribers. We do not offer any corporation or organisation specific Subscriptions. It is a fundamental violation of the Terms of this Policy for a Subscriber to facilitate access to the Subscription Only Content for a third party using their credentials, irrespective of the third-party's ability (or right) to otherwise access the material. Such conduct may lead to the immediate termination of access to the Subscription Only Content and the cancellation of the Subscription, without warning.
